Chief Officer and Chairperson Joint Statement



elcome to the 2023 Annual Report of the Fingal Local Community Development Committee (LCDC). The LCDC has the responsibility of developing and implementing a coherent and integrated approach to local and community development and co-ordinating, planning and overseeing local and community development funding.

Fingal LCDC provides governance, oversight and co-ordination of a number of programmes and funds, including the Social Inclusion and Community Activation Programme (SICAP), the Healthy Ireland Fund and various Community/Local Enhancement funding streams and the Community Recognition Fund, all which are administered by the LCDC secretariat. Oversight and co-ordination of the programmes is supported and augmented by Fingal County Council, Pobal, the Department of Rural & Community Development (DRCD) and the Department of Health.

The Public Participation Network (PPN) continues to develop citizen participation in local decision-making structures with the PPN representatives on the LCDC linking back to the PPN, providing input into decisions taken by the LCDC and allowing the voices of PPN member groups to be heard. This link is vital to the relevance of the LCDC for our communities and the PPN continues to deliver a valuable and positive contribution to civic life in Fingal.

During 2023, the LCDC carried out consultations with stakeholders from community, economic and environmental interests, Elected Members and the public in the preparation of the new Local Economic and Community Plan 2023 – 2028. The latest Census data was used to prepare a new socio-economic profile of Fingal which informs the LECP's high-level goals and objectives. The LECP 2023 – 2028 sets out an ambitious vision for Fingal along with 15 high-level goals, 31 supporting objectives and a series of actions set out in an Implementation Plan for the first two years of the LECP. We would like to thank all the stakeholders, Elected Members and members of the public for their valuable input into the new LECP which provides a strong strategic framework for local economic and community development in Fingal over the next six years. The introduction of an Implementation Plan alongside the LECP framework with a review period of two years represents a welcome opportunity for the LCDC to evaluate progress against the LECP's actions and to reorient the LECP where necessary in response to evolving social and economic circumstances. We look forward to working with all stakeholders over the next six years to realise the LECP vision *"Fingal will be a vibrant, sustainable, progressive and climate resilient county, underpinned by inclusive, healthy, empowered communities and a dynamic economy."*

The SICAP Programme is administrated by Pobal, co-funded by the Irish Government through the Department of Rural and Community Development and the European Social Fund and managed at local level by the LCDC. In 2023 Fingal SICAP was allocated €1,424,714.00 to support interventions to tackle poverty and promote social inclusion and equality at a local level. Fingal SICAP was allocated additional resources to assist with the Ukrainian Refugee Crisis response in the amount of €304,369 with an additional allocation towards the end of 2023 of €65,000. The SICAP Programme Implementer, Empower, achieved its two key performance indicators (KPI's), and ensured that the programme and services were delivered within the financial parameters approved by the LCDC.



In 2023 the LCDC participated in the nationally co-ordinated procurement competition for the provision of new SICAP contracts for the period 2024 - 2028. The existing SICAP Programme Implementer, Empower, were the successful tenderer in Fingal. Fingal LCDC signed contracts with Empower in December 2023 to deliver the SICAP Programme for the period 2024 – 2028 and we look forward to continue work with Empower to provide targeted and innovative supports to disadvantaged individuals and groups in Fingal.

The Dublin Rural Leader Local Action Group (LAG) was established to deliver the LEADER element of the Rural Development Programme (RDP) in the Dublin area. In 2023 the Dublin Rural LAG was successful in its bid to prepare and implement a new LEADER Local Development Strategy (LDS) covering the rural areas of Fingal, South Dublin and Dun Laoghaire Rathdown for the period 2023 - 2027.

The allocated fund for the Dublin Rural area is €4.7 million over this period. During 2023 the Dublin Rural LAG carried out profiling and needs analysis, public consultations, a SWOT analysis and policy analysis. This work informed the development of local development priorities within the new LDS and the LDS main themes of Economic Development and Job Creation, Rural Infrastructure and Social Inclusion and Sustainable Development of the Rural Environment and Climate Change Mitigation and Adaptation.

A budget of €199,622.42 was allocated to the Healthy Ireland Programme in Fingal for 2023-2025. The Healthy Ireland Programme was tasked with a focus on supporting smoking/vaping cessation and a reduction in age standardised heavy episodic drinking over the three years. In 2023, with a budget of €55,622.42, overseen by the Healthy Fingal Coordinator and with the support of the Healthy Fingal Sub Committee, Fingal LCDC, and Fingal Childrens & Young Peoples Services Committee (CYPSC), Healthy Fingal worked with multiple stakeholders to develop and support projects to promote alcohol awareness and the We Quit Programme.

Fingal LCDC administered the Community Support Fund (CSF) of €341,875 in 2023 for current and capital funding streams for groups across the county. Fingal LCDC is also administering the Community Recognition Fund (CRF) over the 2023/2024 period with an allocation of €1,748,912 for 26 projects across Fingal, which must be drawn down by October 2024.

We would like to thank John Quinlivan, Director of Services, Economic Enterprise, Tourism & Cultural Development Department, and the staff of the directorate for their work in supporting the LCDC and partnerships with communities, government agencies, the business community and stakeholder groups for their active engagement and participation on the LCDC, and in particular for their valuable input on the new LECP and new LDS.

Finally, we would like to thank the LCDC members for their continued support during 2023, we look forward to working with all stakeholders in delivering on the objectives and actions in the LECP and LDS and the delivery of other programmes and funding streams in 2024.

Fingal Public Participation Network



Fingal Public Participation Network

Fingal Public Participation Network (PPN) was established in 2014 and is an independent network of community, voluntary, social inclusion and environmental organisations, working to build a better county for the community of Fingal. The PPN is managed by voluntary Secretariat which reports to PPN members through the Plenary. The PPN works to empower the community to be represented in decision making processes that impact citizens through representation on Council committees, consultation processes, policy submissions and more. Most of this work is done through their Linkage Groups.

The PPN acts as an information hub, keeping the community informed of relevant local issues, news, events, resources and supports. We do this through a monthly e-newsletter, bi-annual activity report and the maintenance of our website and social media pages. Fingal PPN has more than 750 members and includes community-based groups, organisations, associations, clubs, societies and charities. Our members are based across Fingal in places such as Blanchardstown, Swords, Balbriggan, Lusk, Rush, Malahide, Howth and more. Membership is renewed every 2 years.

As a PPN, we provide space for community groups to grow and develop through our training supports. We work with local agencies such as Fingal County Council and Empower to deliver training and workshops on topics such as Governance, Grant Writing, Communications, and more. The PPN is funded and supported by Fingal County Council and the Department of Rural and Community Development. You can find out more about our finding and budgets below. The PPN Secretariat proposes the allocation of the PPN budget to the Plenary.

LCDC FUNDING 2023

The Community Supports Fund under the Community Enhancement Programme 2023

The Community Support Fund under the Community Enhancement Programme 2022 was launched on 23rd November 2022 by the Minister for Rural & Community Development, Heather Humphreys TD, and Minister of State, Joe O'Brien, to support Community & Voluntary groups. The Community Support Fund provides small grants to support groups particularly in disadvantaged areas.



The Community Support Fund was administered by the Fingal Local Community Development Committee (LCDC) under the remit of the Local Authority on behalf of the Department of Rural & Community Development. Fingal LCDC received funding of €341,875.00 this amount comprised of current funding (operating and running costs), capital funding, ring fenced women's shed (current) funding & administration fee allocation. See following breakdown.

- Current Funding (Non-Pay) €160,681.00 covering the period 1st April 2022 31st March 2023 for use towards running/operating costs such as utility bills (electricity costs, refuse charges, heating charges) or other non-pay operating costs for e.g., rental/lease costs, insurance bills.
- Capital Funding €160,681.00 for use towards carrying out necessary repairs and improvements to facilities, energy efficiency type projects, purchase of equipment
- Women's Shed ring-fenced funding €3,419.00

Community & Voluntary Groups in the Fingal area were invited to apply for Community Support Funding.

270 groups/organisations submitted applications totalling €888,166.57. All applications were evaluated (viewed & discussed) by the LCDC Evaluation Committee and 174 groups were recommended for Community Support Funding.

Minister of State with responsibility for Community Development and Charities, Joe O'Brien TD, held an event for representatives of successful organisations to announce the 2022 grants allocations in Fingal under the Community Recognition Fund on Friday, May 19, in Donabate Community Centre.















HEALTHY FINGAL





Healthy Ireland is a national government-led strategy aimed at improving the health and wellbeing of everyone living in Ireland. The Healthy Ireland Fund (HIF), funded under the Healthy Ireland national strategy, supports Local Authorities to deliver activities which will improve health and wellbeing locally. Pobal provides funding for HIF Round 4 to each Local Authority and under HIF Round 4, the Local Authority is the contract holder and is accountable for the implementation, oversight and management of the funds awarded, with the Healthy County Coordinator (HCC) and Local Community Development Committee (LCDC) leading out on the planning and implementation. Previous rounds of HIF were primarily activity-led.

In contrast, an outcome-led approach has been introduced to Round 4 to:

- enable the implementation of more targeted and evidence-based activities
- provide a more structured approach to the collection and reporting of relevant data and information which can be used for greater oversight and improved programme evaluation
- provide a clearer understanding of how the work of the funded organisations contributes to HIF programme objectives.



Niall McGuirk was appointed as the new Healthy Fingal Coordinator in December 2022 and was tasked with the development of a workplan for 2023 and a focus on reducing age-standardized heavy episodic drinking and promoting smoking/ vaping cessation for Fingal. The Healthy Fingal budget for 2023 was €55,622.42 with a spend of €34,537.90 which seen deferred funding of €21,084.52 to 2024.



The Healthy Fingal sub-committee is made up of 18 reps from Fingal County Council departments, HSE, Drugs Task Force, Fingal Leader Partnership, Empower, Dublin and Dun Laoghaire Education and Training Board (DDLETB), and Children and Young People's Services Committee (CYPSC). There were 6 meetings held in 2023 with an average attendance of 9 people, which provided an opportunity to network, collaborate and to contribute to a healthier Fingal.

Throughout 2023 Healthy Fingal through Empower attended 7 mass participation community/sports events to promote the We Can Quit programme. This approach has seen information given to 265 individuals on the available quit smoking services. Consequently, only 2 individuals signed up for the programme, and although both individuals who signed up completed and guit smoking, which shows the value and ability of the programme to encourage people to quit, on review it was felt the approach should be more targeted through group contact going forward. Healthy Fingal linked with the HSE Mental health Services to set up a Woodlands for Health programme servicing Balbriggan & Swords, which seen walks developed to assist people in their recovery and signposted to Quit Smoking and alcohol services. Healthy Fingal has worked closely with the Drugs Task Force in North Dublin and Dublin 15 to develop a relationship and devise opportunities to collaborate, and plans are in place to look at developing links with sports clubs as a means of providing information to the community on available services and support and to provide a point of contact in the community for the Drug Task Forces. We are also working on developing a resource to support sports volunteers, teachers and parents to support reduced drug and alcohol use among young people.

Healthy Fingal acquired the services of MediaSocial in June 2023 to assist in the communications of the Healthy Fingal message, develop engagement and improve brand awareness across multiple social media platforms. This has seen the Healthy Fingal Facebook account grow in terms of consistent organic reach and impressions. Engagement levels here are increasing, which is a solid indicator that the content is reaching the right people and is something of interest to them with follower growth slow, but steady. Instagram and Twitter accounts have seen an increase in both tags, mentions, engagement and overall reach and we should have better data in 2024 and access to more key specifics on these accounts. Overall, the accounts are steadily increasing, and we have seen an overall reach of 71,127 across the 321 social media posts made in 2023.





COMMUNITY RECOGNITION FUND



The Community Recognition Fund is adminstered by the Department of Rural and Community Development. It aims to support the development of community infrastructure and facilities for the entire community in recognition of the contribution being made by communities across the country in welcoming and hosting significant numbers of arrivals from Ukraine and other countries. The funding is specifically targeted at projects that are located in cities, towns and villages that are hosting the Beneficiaries of Temporary Protection and/or International Protection Applicants including towns identified for the rapid build homes programme. Fingal County Council received €1,748,912 divided across 26 projects being delivered by 6 FCC Departments. There was an initial drawdown of €178,230.64 in December 2023 with all projects to be completed, remaining funds to be spent and drawdown applications submitted to the Department by November 1st 2024.

SECTION 2 Fingal Local Economic and Community Plan (LECP) 2023-2028



The purpose of the Fingal Local Economic and Community Plan (LECP) is to set out, for a six-year period, the objectives and actions needed to promote and support the economic development and the local and community development of Fingal, both by itself directly and in partnership with other economic and community development stakeholders.

The existing LECP 2016-2022 has come to an end and Guidelines for preparing new LECPs was published by the Department of Rural and Community Development. The new Fingal LECP is a 'Whole-of-Council Plan' and involved extensive consultation and engagement with internal and external stakeholders. A presentation on the guidelines with detailed discussion on next steps was held at the December 2022 meeting of the Economic and Enterprise Development Strategic Policy Committee, following a similar presentation to the LCDC in October 2022.

A Contract Notice was published on e-Tenders on 24th February 2023 using the Open Procedure (non-OJEU) in respect of the Provision of Project Management Consultancy Services for the Fingal Local Economic & Community Plan.

The contract was awarded to Grant Thornton Corporate Finance Ltd, in respect of requirement to purchase/ for provision of Project Management Consultancy Services for the Fingal Local Economic & Community Plan facilitating the consultation process and drafting the LECP and initial 2-year Implementation Plan and a kick-off meeting with Grant Thornton was held in May 2023.





Consultants Grant Thornton commenced work on the preparation of the socio-economic profile of the county for the new LECP, reviewing the last LECP, drafting high-level objectives, facilitating the consultation process and initial 2- year Implementation Plan. Initial consultation on the new Fingal LECP and engagement with internal and external stakeholders took place in June 2023 and the following Sub-Committees were established to collate input to the LECP:

- Economic Sub-Committee
- Community Sub-Committee
- Sustainability/Environment Sub-Committee

Information on the new LECP was also published on the Council's consultation portal in July and was open for submissions. The Council also held a webinar on the new LECP on 22nd July 2023.



A series of stakeholder sessions on the (LECP) 2023-2028 were held during September 2023 for the Council's Elected Members and a presentation on the LECP delivered to the Economic, Enterprise, Tourism & Cultural Development Strategic Policy Committee.

A series of stakeholder consultation sessions on the LECP 2023-2028 were held during November on the draft LECP which was also submitted to the Eastern Midlands Regional Assembly (EMRA) for their input.

The Draft LECP was brought to the January 2024 Council meeting to be adopted by the Council on foot of the recommendations and approval from the Eastern Midlands Regional Assembly (EMRA).

SECTION 3 Social Inclusion Community Activation Programme 2018-2023

The Social Inclusion & Community Activation Programme (SICAP) is a key intervention for harder to reach groups and individuals.

SICAP aims to address poverty, long-term unemployment and social exclusion through local engagement and partnership between disadvantaged individuals, community organisations and public agencies. Delivery of SICAP is overseen and managed by Fingal LCDC. Empower CLG, is the Programme Implementer for SICAP 2018-2023.

The budget for 2023 was €1,383,217 for which a contribution comes from the European Social Fund (ESF) Programme for Employability, Inclusion and Learning (PEIL). The programme implementer achieved its two Key Performance Indicators (KPI's) for 2023 (see table 1 below) and ensured that the programme and services were delivered within the financial parameters approved by the LCDC.

The Horizontal Themes of SICAP are Equality, Community Development and Collaboration. These themes are fundamental to Fingal LCDC and Empowers' values and are evident through the strategies, reviews, programme planning and daily delivery.

GOAL 1: Local Community Groups

Community Groups are supported under Goal 1 of SICAP. Empower work closely with both issue-based community groups and target-group representative community groups and have built significant social capital through intense work over time. This includes developing social capital, directly supporting SICAP target groups to address barriers they have identified and respond to their needs. Through this engagement they have identified the following needs: Access to affordable early-years services; access to affordable and accessible meeting spaces; supports for children and families; poverty and the impact of cost-of-living crisis; racism and discrimination; access to primary health services; lack of youth services; support for people living in Direct Provision.





Fingal LCDC Statement of Priorities, under the Mid-Programme Review, identified the following priority areas: New Communities particularly Asylum Seekers living in Direct Provision, Travellers/Roma, and Early-Years Provision. Table 2 below, displays the breakdown of these target groups who were supported by Fingal SICAP, versus the national average.

Children and families from SICAP target groups were supported through collaboration with representative groups and agencies such as the HSE, TUSLA and Fingal CYPSC to ensure



coordinated response to identified need. The Roma Women's Group, Traveller Women's Groups, Mulhuddart Parent & Child Group and Tyrrelstown Stay and Play Group have all been provided with a broad range of supports including rights-based information and advocacy clinics, Healthy Food Made Easy, Walk & Talk and personal development supports.



GOAL 2: Individuals

Individuals are supported primarily under Goal 2 of SICAP. Empower use a Social Role Valorisation approach to support individuals most in need on a one-to-one basis. This person-centred approach allows individuals to explore their options and choose the most appropriate course of action for them and their families.

The cost-of-living crisis is being experienced by many but exponentially so with SICAP target groups. Individuals have been supported to address food and fuel poverty. The Consumer Price Index (CPI) showed that prices for consumer goods and services was over 7% higher in April 2023 than the previous year. The Balbriggan Food Bank was established by Empower in December 2022. The food bank improves the health outcomes for those living in poverty. 420 adults and 491 children have been supported in 2023. The foodbank is also used to signpost and introduce people to other services within the hub.



SICAP supported 605 individuals experiencing health inequalities through Social Prescribing, Healthy Food Made Easy, We Can Quit and Wellness Recovery Action Planning (WRAP).

Empower has collaborated with the HSE to establish a Roma specific GP and public-health nurse service in Balbriggan.

English language classes were provided to IPA's, Refugees and New Communities who make up 60% of caseload in 2023. Industry specific training and job-seeking skills were provided to 211 people.

SICAP Supports Provided to the Ukrainian Arrivals & International Protection Applicants

Fingal SICAP was allocated additional resources to assist with the Ukrainian Refugee Crisis response in the amount of \leq 304,369 and additional funds of \leq 65,000 towards the end of 2023.

The needs and supports of Ukrainian refugees and International Protection Applicants (IPA's) are complex and varied. Both Ukrainian refugees and IPA's on average experience more barriers than other target groups as evidenced in Table 3. Additional barriers facing them include racism, difficulties in recognising qualifications, accessing suitable accommodation, legal advice, mental health, and language barriers. The SICAP Personal Action Plan helps to identify their needs and put in place appropriate supports. For many, employment and financial independence is the primary need.

Mental illness and wellbeing issues are also more prevalent for these groups. Empower organise social activities such as trips to cultural and recreational sites. This promotes integration and positive wellbeing.

The SICAP team collaborate with Fingal County Council, HSE Social Inclusion section and multiple agencies and community groups to ensure a coordinated response and maximise resources in response to identified needs. Frontline SICAP team members have completed the Immigrant Council of Ireland Anti-Trafficking Training and INAR's Anti-Racism and iReport training.

SECTION 4 The Dublin Rural Leader Local Action Group


The Dublin Rural Local Action Group (LAG) was established to deliver the LEADER element of the Rural Development Programme (RDP) for the period 2014–2022 in the Dublin Rural Region. The LEADER Programme aims to improve the quality of life in rural areas and to encourage diversification of economic activity in rural areas.

2023 was a positive, productive, and busy year for Dublin Rural LEADER. The funding continued to support community groups and enterprises across Rural Dublin, with 80% of the projects successfully completed by end of 2023. The LAG commenced the application for the new 2023-2027 LEADER Programme. This resulted in numerous workshops and stakeholder events to ensure the Local Development Strategy for Rural Dublin reflects the growing needs and issues facing the communities and citizens. The year ended on a high with news that Dublin Rural LEADER had been successful in the application process and would be delivering the new programme commencing in early 2024!

A high-level breakdown of the LEADER 2014-2022 Programme:

- Total number of projects approved under the Programme was 127 and the value of €6.87million.

Project Description

Rush Dramatic Society has been in existence for 95 years. The venue was built in 1988 with a €1.2m upgrade in 2004. In 2027 Millbank Theatre will celebrate 100 years in the community. Millbank Theatre runs a varied schedule of programming at the theatre with limited staffing and funding resources that include: Theatre Productions (Amateur and Professional), Musical Productions and GIGS, Art House Cinema, Drama Classes from 8 to 18, Seminar and Conference facilities (Currently used by An GARDA College facilities Templemore), A new Filming Project and Acting for Camera Classes as well as theatre hire for Charities, (Prosper Fingal), local groups and clubs fundraising nights (e.g. FOROIGE).

Their sound and projection equipment were old, obsolete, and cumbersome. It was acquired from a philanthropic donation 7 years ago. While satisfactory it couldn't keep up with changing technologies. The project involved the purchase of new cinema equipment, including cinema surround-sound speakers and a projector.



With this Cinema Project, the Promoter grew the Art House cinema aspect to the existing services and screened movies on a more regular basis. The new equipment greatly enhanced the

audience experience, allowing to screen 4kHD and higher resolution formats, and to stream movies other than DVD showings.

The Promoter extended their offering amongst a wide range of diverse ethnic audiences reaching out to many language groups, Irish film creators, teenagers, and Children. The Organisation learned since the lockdown of the Pandemic that people enjoyed coming back to a safe controlled environment in which to watch quality independent films.

Project Description

Lusk has rapidly expanded in the last 15 years and all of infrastructure, amenities and facilities are struggling to catch up. This has resulted in a fractured community, especially so in the aftermath of Covid. In the 2021 "Lusk Vision 2030" survey, funded by LEADER, it was found that 50% of people in Lusk felt that they had no connection to it.

The main goal of this event was to provide the people of Lusk with an opportunity to return to something normal and fun following the last two years of Covid.



It gave people the opportunity to meet socially in an outdoor environment where the focus was on the presentation of local business, food, entertainment & groups.

Activities included:

- children's section with a hay bale maze, giant games, teddy bears picnic, face painting
- carnival games
- food area with food vans that will include picnic benches & waste bins
- local food produce vans
- local small business stalls
- multicultural area (including Lusk non-Irish-born population presenting aspects of their culture, dance, and music, etc)
- music and entertainment segment with local musicians, bands, groups, choirs, dance schools etc.
- Tango dancing and instruction
- Different sporting groups and community groups in competition in Tug-of-war.
- Showcase of vintage cars and tractors

Project Description

Climate change is challenging our society both nationally and locally in County Dublin. It is necessary to mitigate against and adapt to the impacts of climate change, as well as to capitalise on any opportunities which may emerge. The challenges of climate change should not be underestimated and will require communities to be supported to transition our society to a low-carbon, climate resilient one. A ground-up, community-led approach will be needed to achieve this transition. Taking proactive action to adjust and prepare for anticipated changes will reduce losses, improve our environment, and provide a host of community benefits. Global momentum is building for national and local governments to take ambitious action that builds resilience to climate change within their organisations and functional areas via adaptation and mitigation measures. Developing a robust approach to adaptation is the first step on this journey.



The role of individuals and local communities is vitally important to identifying risks, challenges and opportunities that need to be considered in communities and to take coherent coordinated action. Many local community groups are becoming more active in Climate Action projects and are becoming increasingly aware that they need to act. Some individuals and Community Groups are already working on projects but may need support to drive them forward or to connect them to other local or regional projects.



More awareness is needed within communities specifically identifying local realistic actions. Fingal LEADER Partnership CLG (FLP) delivered the course across villages in the Dublin Rural Leader Operational areas of Fingal, South Dublin and Dún Laoghaire-Rathdown to 88 participants.
